my dutch oven. To my son in law **John Fullilove** my cupboard, one large iron pot, my belmettle Skillet, & to his daughter **Susanah Fullilove** one half dozen mettie plates, & half dozen spoons. To my brother **Stephen Tatom** 10 pounds. To my sister **Nanney Graves** my saddle & blew wooling gound & one pair of leather woden heal^d shews, one pair of thread stockings. My daughter in law **Elizabeth Blalock** one large trunk & four chares & my cross bard petticoat, one capt, & handkerchief, & apron. To my sister **Jemima Carrington** my black calico gound. To my cousin **Agness Hicks** two cotton shifts, one pale blew woolen gound & stript woolen petticoat. To my cousin **Susanah Graves** my white Hollan gound, one large Hollan apro, my gold ring, a purple floward ribbon, & 40 shillings Virginia money. To my sister **Sarah Chandler** 40 shillings Virginia money. To my brother **Benjamin Tatom** 5 pounds Virginia money & if he has Eiry one of his daughers **Susanah** I give her 5 pounds and if not, nothing. Leave between my cousin **Hennerita Fullilove** & **Winneyfret Addams** my two stript Hollon gounds & a stuff gound, two black handkerchiefs, one par of black gloves, one guaze ribband to be equally divided between them, & two pair of thred stockings to **Hennerita Fullilove**. My black cap to **Kezia Goodwin**, my black quilt to **John Tatom** wife, one corse linen shift & my lin handerchief. To **Elizabeth Ann Tatom** to buy her a skir of what cololer she chuset, one pair of gloves, & 20 shillings to buy her a ring. To **Salley Fullilove** & **Nancy Fullilove** one gound & 20 shillings cash to make each of them a ring. To my brother **John Tatom** 8 pounds. To my sister **Nancey Graves** & to her two son **John Graves** & **Stephen Graves** 12 pounds to be delivered to her at 20 shillings p^f year. To **Jemima Carrington** 40 shillings. What remains over to my son in law **John Fullilove** and his two sons **Tho^s Fullilove** & **Ludwell Fullilove**. My brother **John Tatom** Executor.

129. **LOVIT GATES**, 10 December 1788.

The whole of my Estate after debts paid, the remainder land, Negro, stock of all sorts and household furniture of every sort I lend to my beloved wife **Dianer Gates** during her natural life and what remains at her death I dispose of as follows: **Lovit Reed** or his heirs to have in cash V[irginia] money or the value thereof 10 pounds out of my Estate. To **Thomas Grinaway Jun^r** the rest of my Estate. My beloved wife **Dianer Gates** my Ex^{tor}.

130. **WILLIAM GILLIAM** of Granville County, North Carolina, 12 October 1778.

Lend my whole Estate to my wife **Agness Gilliam** as long as she doth live. To my son **William Gilliam** all my carpenter's & cooper's tools, one gun (at my death) and after my wife's death my Negro fellow **Andrew** if he be alive. What sheep that then be alive be equally divided between my son **Harris Gilliam** & **William Gilliam**. To my grandson **Drewry Kimball** one bed, bedsted cord, two sheets and a rug. To my grand daughter **Amy Gilliam** one side saddle. As to the stock after my death & wife's, that is to say hogs, cattle, horses, corn, & all the rest of my Estate not given away in legacys be sold & the money equally divided amongst my four children **Harris, Winny, William, & Agness**. Exectuors my well beloved wife **Agness Gilliam**, son **William Gilliam**, & **Christopher Robinson**.

February 1781 proved by the oath of **William Neal**. **William Gilliam** and **Christopher Robinson** qualified as Executors.

131. **WILLIAM GILLIAM** of Granville County, North Carolina, 1 June 1803

Lend to my well beloved wife **Elizebeth Gilliam** all my land lying on the East side of the road leading from **Gilliam's Meeting House** to **Joseph Daniel's gate**, 5 Negroes man **Isaac**, two women **Rachel** and **Dol**, one boy **Ned**, and one girl **Liller**, all my stock of horses, cattle, hogs, sheep, and oxen, and all my household & kitchen furniture of every kind, all my plantation and other tools of very kind during her life or widow hood. To my son **William Gilliam** after the death or marriage of his mother, all my land on the East side of the road leading from **Gilliam's Meeting House** to **Joseph Daniel's gate**, one sorrel horse which is now called his horse. To my son **William Gilliam** Negro lad **Jerry** and young woman **Frankey** & their future increase, & my square barrel gun. To my son **Lesley Gilliam** all my lands on the West side of the road leading from **Gilliam's Meeting House** to **Joseph Daniel's gate**, Negro man **Harry**, and after the death or marriage of his mother a Negro woman **Dol**, her two children **Jenny** & **Phil**, and their future increase. **Lesley** is to have the increase of **Doll** at my death, my sorrel mare blaze after the death of his mother. To my daughter **Amey Harrison** after the death or marriage of her mother my Negro man **Isaac**. To my daughter **Presciller Harris** my Negro girl **Chinea** & her future increase. To my daughter **Elizebeth Harris** my Negro boy **Austin**. To my daughter **Dolley King** \$1. To my daughter **Delilah Thorn** \$1. To my daughter **Lundy Sims** my Negro girl **Peggy** and her increase. After the death or marriage of my wife three respectable men value Negroes **Rachel, Ned, & Siller** & their future increase and the money arising from valuation be equally divided between my daughter **Lundy Sims** and my grandson **John Leon King** and my grand daughter **Elizebeth**
